The Navajo Nation Business Opportunity Source List is updated on a monthly basis, pursuant to Navajo Nation Council Resolution CAP-37-02 and the Navajo Nation Business Opportunity Act, Title 5, CH. 2 - Sect. 201 - 215.

This Source List provides a listing of Persons, Firms, Enterprises, Organizations, and/or Other entities currently certified by the Business Regulatory Department as prioritized under Section 204 (A) (1) and (2) of the revised Navajo Nation Business Opportunity Act.

### **Preference Priorities Section 204 (A)**

**(1) Priority #1:**

Certification shall be granted to any 100% Navajo-owned and controlled business, having its principal place of business on or off the Navajo Nation.

**(2) Priority #2:**

Certification shall be granted to any 51% to 99% Navajo or 51% to 100% other Indian owned and controlled business or 100% Navajo Nation owned and controlled economic enterprise having its principal place of business on or off the Navajo Nation.
